Surveyors in case of disasters




- In advance: Hazard Maps, Detecting Deformation etc.



Population (Thousand persons)




Temporal variation of Japanese population After Government of Japan. e-stat (2023)





Way to obtain license of surveyor or assistant surveyor Simplified diagram based on Survey Act


Number of newly registered surveyors and assistant surveyors

Public expenditure for Survey




Economical situation is of course important

- 2000 was a year of restructuring Japanese administrative organization
- 2001 was a year of recession triggered by end of IT bubble
- Public expenditure in survey remarkably decreased
- Decrease of recruitment affects new registration of surveyors and assistant surveyors
- Even so, Survey companies face insufficient human resources today

■ surveyors are in sufficient




Encourage young students select survey for their profession is necessary
